One award application is offered for alumnae groups to use to apply for the following two awards:

- 1. "The Maggie" Newsletter Award (Alumnae Division)
- 2. Barbara Nussa Boersma Outstanding Technology Award (Alumnae Division)

Please read the criteria for each available award to ensure your group is eligible to apply.

# "THE MAGGIE" NEWSLETTER AWARD (ALUMNAE DIVISION)

## Purpose

To recognize the outstanding alumnae chapter/association newsletter in paper and/or electronic format. The Maggie Newsletter award is named for former Fraternity Executive Director **Margaret** "Maggie" Hess Watkins, Alpha Xi-West Virginia.

### Criteria

- Be in good standing with the required number of members and events, fees paid and Anchorbase updates completed.
- Produce a newsletter in paper and/or electronic format at least two (2) times in the (2022-24) biennium (examples required).

# BARBARA NUSSA BOERSMA OUTSTANDING TECHNOLOGY AWARD (ALUMNAE DIVISION)

### Purpose

The award recognizes a chapter for the innovative use of technology to benefit their chapter. Special consideration will be given to chapters for solutions that can be shared/implemented throughout the Fraternity. Technology may include, but not limited to: apps, social media, video, website, email, etc.

### Criteria

- Be in good standing with the required number of members and events, fees paid and Anchorbase updates completed.
- Use technology in an innovative way to benefit the chapter.

### ASSEMBLING THE APPLICATION FOR BOTH AWARDS

- It may be helpful to compose the full submission information in a Word document that may be revisited and saved.
- The online application may be accessed/completed via desktop, laptop and/or iPad devices.
- · Review the online application to familiarze yourself and prepare all required information.
  - ° Go to Anchorbase and click on the "Awards" menu at the top.
  - ° Select "Tasks" and then "Alumnae Communication and Technology Awards".
- It is strongly recommended that nominators do not wait until the intended date of submission to access the online application for the first time.
- · Online application supports uploads in the following formats.
  - ° .pdf
  - ° .doc and .docx
  - ° .xls and .xlsx
  - ° All other file formats should be converted to a pdf before uploading.

## Submitting the application

- · Applications may be submitted only by a Delta Gamma alumnae group officer.
  - ° If a nominator does not have Anchorbase access, please contact the Director: Awards at awards@deltagamma.org for assitance.
- · Applications must be submitted online through Anchorbase.
- The application deadline is 11:59 p.m. on May 1, 2024 (in the submitter's time zone). This is a firm deadline.
