



Welcome, Leadership!

We appreciate your commitment to Delta Gamma Fraternity and look forward to a close working relationship with you.

Following The Leadership Collective (TLC), there are several important action items and reminders to ensure a smooth financial close to our fiscal year and compliance with IRS guidelines.

All TLC attendees must submit their expense reports no later than July 30, 2025. Our fiscal year ends on June 30 and timely submission is essential to close our books and prepare for our annual audit. Reimbursement requests submitted after July 30 may not be honored.

The IRS requires that reimbursable expenses be submitted within 60 days of being incurred. Any expenses submitted after this window may be considered taxable income and could result in the issuance of a 1099 form. To avoid this, we strongly encourage you to submit your expense report within 30 days of incurring an expense.

Please retain a copy of your expense reports and all associated receipts for your records. If you are unable to fulfill your term and have incurred Fraternity-funded expenses, you may be asked to reimburse the Fraternity.

All members traveling on behalf of Delta Gamma must complete a trip report detailing the work performed. These reports are essential for substantiating expenses and are archived in Anchorbase for seven years. A Council member may designate one person to submit a group trip report. Please note that trip reports are not required for Convention, The Leadership Collective or other Delta Gamma trainings. In most cases, expense reimbursements will not be processed until the trip report is uploaded.

You can find Fraternity finance resources in the Leadership Handbook and the Delta Gamma library.

To remain in good standing, all members of Leadership must pay annual per capita dues of \$46 for the fiscal year July 1, 2025-June 30, 2026. Dues can be paid online at deltagamma.org. Please note that this amount may increase due to a Constitutional amendment passed at Convention 2006.

Once again, thank you for giving so selflessly of yourself. Your leadership makes a lasting impact and we are here to support you every step of the way. Please don't hesitate to reach out with any questions or if we can be of further assistance.

Foundation Leadership Finances



Welcome, Leadership!

We are excited to work with those continuing in their appointed roles and those new to the Foundation team. As we begin the new fiscal year, there are a few financial housekeeping items to keep in mind.

The IRS has a strict 60-day filing deadline for reimbursable expenses. This means expenses must be reimbursed within 60 days of the date of purchase, not necessarily the date of use. If not reimbursed within 60 days, the reimbursement may need to be reported on a 1099-NEC as taxable income. We ask that you submit an expense report within 30 days of any reimbursable purchase to ensure that payment is processed for you within the 60-day filing period.

Your program includes the Foundation expense report form, along with instructions and Frequently Asked Questions. Also included is the Foundation's Schedule of Allowances which will guide you in planning costeffective travel as a steward of the Foundation.

If you have Foundation expenses you do not want reimbursed, please submit an expense report and request the reimbursement be given as a donation to the Foundation. This informs us of your role's travel expenses for future budgeting purposes and allows you to receive recognition for the donation.

If you have questions, please reach out to us at any time. We are here to help.

Trustees are required to disclose in writing any potential conflicts of interest.

The Fraternity Nominating Committee is responsible for receiving and processing nominations, then developing a slate of candidates for the Fraternity Council. The committee is composed of one representative from each of the Fraternity's eight geographic regions. Each committee member was elected by the Convention delegates in their region at Convention 2024 to serve until Convention 2026. Fraternity Council appoints the committee chair.

How to Nominate



Step 1: Think About DG Alumnae Who Inspire You

Think about alumnae sisters whom you feel would make outstanding Fraternity leaders. Perhaps they are a mentor, adviser, alumnae officer or community leader who embodies Delta Gamma's mission and would bring valuable leadership to this role. Nominating this sister is the first step!

To be considered, a member must be nominated through the official form. Nominees will then be invited to accept and complete a Council Interest Form should they wish to continue on in the slating process.

Who makes a strong candidate?

Ideal candidates typically:

- · Hold leadership roles in their professional or volunteer lives
- · Understand Delta Gamma's vision, mission and values
- · Possess characteristics that support effective Council service

To assist with your nomination of qualified candidates, the Fraternity Nominating Committee developed three themes and a list of core leadership competencies that represent some characteristics that would be helpful as a Council member. These can be found at the top of the official nomination form. You can also learn more about the role of a Council member in the Volunteer Position Description Handbook located in the DG library.

Step 2: Fill Out the Official Nomination Form

Beginning July 1, you can access the official nomination form on the How to Volunteer for DG section of the Delta Gamma website. The nomination form allows you to submit up to ten (10) nominations at a time. To submit more than ten (10) nominations, you must complete a second form.

You may nominate an alumna for more than one Council position. You may also nominate more than one alumna for the same Council position. For example, you may nominate Eva for President and Council Trustee: Communications, while also nominating Mary for Council Trustee: Communications. Nominations must be received by 11:59 p.m. PST on November 1, 2025. All nominees will be notified of their nomination after the submission deadline has passed.

Our Constitution

The Constitution provides guidance to the nomination and election process.

ARTICLE X. ELECTION. TERM AND VACANCIES

Section 1. Nominating Committee

C. Prior to April 15 in the Convention year, the Nominating Committee shall present to the delegates at least one, but not limited to one, candidate for each office to be filled. The name of each candidate shall be accompanied by a statement of the candidate's qualifications for the Council office for which the nomination was made.

Section 2. Nominations by members

Following the presentation of the Nominating Committee's Council slate to the members, any two members may submit a nomination by filing the required forms with Executive Offices by the 14th day after the date aforementioned slate is presented. Such nominations and qualifications shall be presented in the same manner as the Nominating Committee's slate and shall be included in a pre-Convention mailing. There shall be no nominations from the floor.

Section 3. Election and term

B. Only alumnae members shall be eligible for office. No elected officer may serve more than four terms on Council, serving either consecutive or non-consecutive terms. No elected officer may serve more than two terms in the same office.

November 2, 2025 Council Interest Form and other required materials will be sent to all eligible nominated candidates

December 1, 2025 All required candidate materials must be received by the Nominating Committee

December 2025-January 2026 Nominee Evaluation Survey sent to all members to provide feedback on nominated candidates

February 2026 Nominating Committee conducts interviews

March 6-8, 2026 Nominating Committee prepares the slate

Before April 15, 2026 As required by the Fraternity Constitution, the slate is announced/distributed via Executive Offices. By the 14th day after the slate is presented, nominations by membership must be received by Executive Offices

June 2026 Convention delegates elect 2026-28 Council in Dallas/Fort Worth, Texas
